1. Rules

The regatta will be governed by the rules as defined in the Racing Rules of Sailing and the SBSC general byelaws. Competitors will also behave in accordance with the RYA Racing Charter.

2. Entries

- 2.1. Pre-entries only will be accepted and should be received by Thursday 15th April 2021.
- 2.2. Entries can be made by returning the completed entry form to the administrator at Stokes Bay Sailing Club by email or post. Payment can be made by bank transfer or credit/debit card as described on the entry form.

3. Schedule of Races

4. Sailing Instructions

Sailing Instructions will be available on the Club's website from Thursday 15th April 2021.

5. Scoring System

- 5.1 The low point scoring system of Appendix A will apply.
- 5.2 Two races must be completed to constitute a series.
- 5.3 If three or more races are sailed there will be one discard. If only two races are sailed both will count towards the overall result.

6. Prizes

Prizes will be awarded dependant on the number of entries after the conclusion of the last race.

7. Rights to use Names & Likenesses

Competitors automatically grant to the organising authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

8. Conditions of Entry

- 8.1 Competitors are entirely responsibly for their own safety, whether afloat or ashore and nothing, whether in the Notice of Race or Sailing Instructions or, anywhere else reduces this responsibility.
- 8.2 It is for the competitors to decide whether their boat is fit to sail in the conditions in which it will find itself. By launching or going afloat, the competitors confirm that their boat is fit for those conditions and that they are competent to sail and compete in them.
- 8.3 Nothing done by the organisers can reduce the responsibility of the owners and/or competitors, nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race and the event, and include Stokes Bay Sailing Club, the organising authority, the race committee, the race officer, patrol boats and beach masters.
- 8.4 The provision of patrol boats does not relieve the boat of her responsibilities.
- 8.5 Each boat is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least £3,000,000.
- 8.6 **Covid-19** - All competitors and their guests shall comply with Government laws and guidelines, RYA guidelines and Club rules and guidelines that may be in place at the time of the event.
